

Public Interest Statement
Application for *Pro Forma* Assignment of Licenses

Sprint Corporation (“Sprint”), on behalf of its wholly owned subsidiaries described herein (“Sprint Licensee Subsidiaries” or “Assignors”), hereby provides notice to the Federal Communications Commission (“FCC” or “Commission”) of the *pro forma* partial assignment of certain common carrier licenses in the Broadband Radio Service (“BRS”) pursuant to the forbearance procedures of 47 C.F.R. § 1.948(c)(1).¹

Sprint is undertaking a *pro forma* internal reorganization affecting certain wireless licenses, leases, and other assets. As part of this reorganization, certain licenses held by the Sprint Licensee Subsidiaries are to be partially assigned to Sprint Spectrum License Holder LLC (“Assignee”), a new wholly owned subsidiary of Sprint.² Partial assignment of these licenses from one wholly owned Sprint subsidiary to a different wholly owned Sprint subsidiary is considered to be *pro forma* under the Commission’s rules and precedent, as there will be no “substantial change in ownership or control.”³ Ultimate control of the licenses will remain with Sprint, and neither *de jure* nor *de facto* control of the licenses will change.

The following subsidiaries hold the BRS licenses that are to be partially assigned to Sprint Spectrum License Holder LLC:

All of the Sprint Licensee Subsidiaries and the Assignee are wholly owned subsidiaries of Sprint. Sprint is a publicly traded Delaware corporation and global communications company that, through its subsidiaries, offers a comprehensive range of wireless and wireline voice and data products and services to residential, business, government, and reseller consumers throughout the United States and around the world. Sprint offers wireless and/or wireline voice and data services in all fifty states, the District of Columbia, Puerto Rico, and the U.S. Virgin Islands. Sprint is primarily a holding company, with most operations conducted by its subsidiaries. Sprint holds numerous wireless licenses through its various subsidiaries, and its qualifications are a matter of public record.⁴

Because partial assignment of licenses from one Sprint Licensee Subsidiary to another is *pro forma* in nature, and “no substantial change of control is involved,” it falls presumptively within the public interest.⁵ Sprint therefore respectfully requests that the FCC promptly consent to the *pro forma* partial assignment of the licenses described above to Sprint Spectrum License Holder LLC.
