DESCRIPTION OF TRANSACTION AND PUBLIC INTEREST STATEMENT

On September 14, 2015, affiliates of AT&T Inc. ("AT&T") and T-Mobile USA, Inc. ("T-Mobile") entered into an agreement ("Exchange Agreement") to exchange certain PCS and AWS-1 licenses ("Assigned Spectrum") in various markets ("Markets"). These swaps are intended to enable more efficient operations by creating larger blocks of contiguous spectrum and aligning spectrum blocks across markets. Identical amounts and types of spectrum are being swapped in each Market. Thus, upon the consummation of the transaction contemplated by the Exchange Agreement, the attributable spectrum holdings of AT&T and T-Mobile will be unchanged.

The foregoing FCC Forms 608 notify the Federal Communications Commission ("FCC" or "Commission") of a short term spectrum manager lease agreement ("Lease Agreement") for some of the Assigned Spectrum. Under the Lease Agreement, four AT&T affiliates -- New Cingular Wireless PCS, LLC, AT&T Mobility Spectrum LLC, Cingular Wireless of Texas RSA #16 Limited Partnership and Texas RSA 19 Limited Partnership (collectively, "Licensees" or "Lessors") -- have agreed to lease certain licenses (the "Leased Spectrum") to two T-Mobile affiliates -- T-Mobile License LLC and T-Mobile Puerto Rico LLC (collectively, "Lessees"). Separately filed Forms 608 will notify the Commission of another short term spectrum manager lease agreement ("Companion Lease Agreement") under which identical types and amounts of spectrum will be leased from T-Mobile affiliates to AT&T affiliates. Thus, collectively, the Lease Agreement and the Companion Lease Agreement, like the Exchange Agreement itself, will result in no change in the amounts and types of spectrum attributable to AT&T and T-Mobile.¹

Lessors and Lessees have entered into the Lease Agreement in order to (i) grant Lessees the right to use the Leased Spectrum pending the closing of the Exchange Agreement and thus further expedite the deployment of the spectrum and the resulting public interest benefits, and (ii) memorialize the respective rights and responsibilities of Lessors and Lessees with respect to the Leased Spectrum consistent with the Communications Act of 1934, as amended, and the rules, regulations and policies of the FCC (the "Communications Laws") and the terms and conditions set forth herein.

The commencement date will vary across the Markets based on the parties' ability to clear the spectrum and retune their radios. In no circumstance will the commencement date occur prior to the expiration or early termination of the waiting period under the

Hart-Scott-Rodino Antitrust Improvements Act of 1976 for the transactions contemplated by the Exchange Agreement. The Lease Agreement will expire on the earlier of September 15, 2016 or the closing of the transactions contemplated by the Exchange Agreement for a particular Market. The Lease Agreement is subject to early termination in certain circumstances, and the parties intend to file the cancellation notices as appropriate and in accordance with the FCC's rules.

Consistent with the Lease Agreement and the requirements of the Communications Laws, Lessors, whose qualifications and eligibility as a licensee are matters of Commission record, will retain *de facto* and *de jure* control of the Leased Spectrum throughout the lease term. Lessees, whose qualifications and eligibility also are matters of Commission record, will conduct operations under the Lease Agreement subject to applicable rules and regulations.

No competitive harm will result by the proposed leasing arrangement. Any change in access to spectrum under the Lease Agreement will be offset by the Companion Lease Agreement. In each Market, T-Mobile's overall spectrum aggregation post-lease will remain below current levels requiring further competitive review. Moreover, the transaction does not raise any low band spectrum aggregation concerns since it involves only PCS and AWS-1 spectrum. ² See Appendix A, which shows the collective spectrum aggregation for AT&T and T-Mobile under the Exchange Agreement in the counties implicated by these Forms 608. In addition, as Appendix B illustrates, numerous other carriers, including the other national carriers, hold spectrum in the Markets.

Finally, because Licensees will transition existing operations on the Leased Spectrum to other spectrum that they are leasing from Lessees or their affiliates in the same Markets, there will be no discontinuance, reduction, loss or impairment of service to customers. Therefore, there are no customer transition issues relating to this leasing arrangement.

Foreign Ownership

Each Lessee is a wholly-owned subsidiary of T-Mobile. T-Mobile in turn is a wholly owned direct subsidiary of T-Mobile US, Inc. ("<u>T-Mobile US</u>"), a U.S.-organized entity. Deutsche Telekom AG ("<u>DT</u>"), a publicly-traded German corporation, holds a 65.58 percent interest in T-Mobile US through its wholly-owned subsidiary T-Mobile

Global Zwischenholding GmbH ("<u>T-Mobile Global</u>"). This subsidiary owns all of the equity and voting interests of T-Mobile Global Holding GmbH ("<u>T-Mobile Holding</u>"), which owns all of the equity and voting interests of Deutsche Telekom Holding B.V. ("<u>DT Holding B.V.</u>"), which in turn holds the 65.58 percent interest in T-Mobile US. The remaining 34.42 percent interest in T-Mobile US is held by public shareholders. Thus, through DT, foreign entities and persons indirectly hold 65.58 percent of the attributable ownership interests in T-Mobile US and T-Mobile.

On December 30, 2013, the Commission granted, subject to certain conditions, T-Mobile US's Petition for Declaratory Ruling under Section 310(b)(4) of the Communications Act on behalf of its subsidiaries and affiliates holding common carrier radio licenses that it would not serve the public interest to prohibit more than 25 percent foreign ownership in T-Mobile US.⁴ That ruling also specifically permitted: (i) the specific foreign entities with a non-controlling interest in T-Mobile US (i.e., Kreditanstalt für Wiederaufbau and the Federal Republic of Germany ("FRG")), to increase their equity and/or voting interests, at some future time up to and including a non-controlling indirect 49.99 percent equity and/or voting interest; and (ii) the specific foreign entities with a controlling interest in T-Mobile US (i.e., DT Holding B.V., T-Mobile Holding, T-Mobile Global and DT) to increase their interests, at some future time, up to and including 100 percent of T-Mobile US's equity and/or voting interests.⁵ T-Mobile US's petition was filed in connection with an internal corporate reorganization that resulted in the insertion of a new direct parent company, DT Holding B.V., a limited liability company organized in the Netherlands, into T-Mobile US's ownership chain. That declaratory ruling includes all authority available under the rules, including the standard terms and conditions set forth in Section 1.994 of the rules, and thus extends to Lessees (among other licensee subsidiaries of T-Mobile) and the type of wireless service licenses that are the subject of the instant transaction. The foreign ownership in the Lessees as approved has not materially changed since December 30, 2013 and will not be affected by the instant transaction.

DOJ/FBI/DOD Agreement

Lessees also request that the Commission condition its acceptance of this lease notice on compliance with the provisions of the Agreement entered into on January 12, 2001, as amended, between DT, VoiceStream Wireless Corporation and VoiceStream Wireless Holding Corporation, on the one hand, and the Department of Justice and the

Federal Bureau of Investigation on the other (the "<u>Agreement</u>").⁶ The Agreement prescribed that the following specific language be included in the conditional grant of interests in FCC licenses in the specific context of the Agreement:

It is further ordered, that the authorizations and the licenses related thereto are subject to compliance with the provisions of the Agreement attached hereto between Deutsche Telekom AG, VoiceStream Wireless Corporation, VoiceStream Wireless Holding Corporation on the one hand, and the Department of Justice (the "DOJ") and the Federal Bureau of Investigation (the "FBI") on the other, dated January 12, 2001, which Agreement is designed to address national security, law enforcement, and public safety issues of the FBI and the DOJ regarding the authority granted herein. Nothing in the Agreement is intended to limit any obligation imposed by Federal law or regulation including, but not limited to, 47 U.S.C. § 222(a) and (c)(1) and the FCC's implementing regulations.⁷

Lessees hereby request that the Commission impose a similar condition on its acceptance of this lease arrangement.

Conclusion

The Parties respectfully submit that Lessees are qualified to operate the Leased Spectrum and that Commission acceptance of the lease arrangement will serve the public interest, convenience and necessity.⁸
