Executive Summary

Atlantic Environmental Services, Inc. (AES), conducted a Phase I Environmental Site Assessment (ESA) for a 2,500-sqft lease area for the construction of a 195-foot monopole wireless communications facility adjacent to 7437 Carpenter Fire Station Road, Cary, North Carolina, in Wake County. The subject property is an approximate 50-foot by 50-foot lease area (the Site) to be leased by PT Access Networks on the south side of a Progress Energy electrical substation. The Site includes an access easement from Carpenter Fire Station Road.

The objective of a Phase I ESA is to identify recognized environmental conditions for a subject site. A recognized environmental condition is defined in ASTM standard E-1527 as “the presence or likely presence of any hazardous substances or petroleum products on a property under conditions that indicate an existing release, a past release, or a material threat of release of any hazardous substances or petroleum products into structures on the property, or into the ground, groundwater, or surface water of the property.”

A site reconnaissance was conducted on September 18, 2012. The site inspection of the property and surrounding area and the information provided to AES indicated the following:

- The Site is a 50-foot by 50-foot lease area consisting of a wooded slope adjacent to an electrical substation. The parent property, consisting of two parcels, measures approximately 24-acres and is currently owned by Carolina Power & Light Company (Progress Energy).
- The Site includes a 20-foot by +/-1,000-foot access and utilities easement from Carpenter Fire Station Road, mostly following the existing substation access road.
- The property surrounding the Site consists of single and multifamily residential use among undeveloped woodlands and the NC Highway 540 corridor.
- Progress Energy provides electricity in the area and AT&T provides landline telecommunication service. Water service is not in use at the Site. Wastewater service is also not in use at the Site. Both services are likely available in the area from the Town of Cary Public Works and Utilities.

Topography at the Site slopes to the south toward a tributary of Panther Creek.

- Mr. Chris Seawell of PT Access Networks was contacted to obtain further information about the historical use of the Site. Mr. Seawell indicated that he is not aware of any environmental conditions on the property and reported no knowledge of a previous Phase I ESA or environmental conditions, liens, or activity use restrictions.
- The surrounding area was found to include no mapped, but several unmapped records in the state and federal environmental databases searched per ASTM standards. Based on a location assessment and status of these records, it has been determined that they are not expected to affect the lease area.
- This Phase I Environmental Site Assessment was performed in conformance with the scope and limitations of ASTM Practice E 1527 for the subject lease area. Any exceptions to, or deletions from, this practice are described in Sections 2.4, 3.5.2 and 3.6. This assessment has revealed no evidence of recognized environmental conditions in connection with the lease area.

1. Introduction

Atlantic Environmental Services, Inc. (AES), conducted a Phase I Environmental Site Assessment (ESA) for a 2,500-sqft lease area for the construction of a 195-foot wireless telecommunications facility addressed as 7437 Carpenter Fire Station Road, Cary, North Carolina, in Wake County. The subject is an approximate 50-foot by 50-foot lease area (the Site) on the south side of a Progress Energy electrical substation. The Site also includes an access easement from Carpenter Fire Station Road.

This Phase I ESA was conducted in accordance with the American Society for Testing and Materials (ASTM) standards for environmental site assessments for commercial real estate (E 1527-05). The objective of a Phase I ESA is to identify recognized environmental conditions for a subject site. A recognized environmental condition is defined in ASTM standard E-1527 as “the presence or likely presence of any hazardous substances or petroleum products on a property under conditions that indicate an existing release, a past release, or a material threat of release of any hazardous substances or petroleum products into structures on the property, or into the ground, groundwater, or surface water of the property.”

AES conducted a walk-through inspection of the property on September 18, 2012, to evaluate existing site conditions. A search of the United States Environmental Protection Agency (USEPA) and South Carolina state regulatory environmental databases for the area was conducted by Environmental Data Resources, Inc. (EDR). The following sections discuss our research in detail.

Detailed Scope of Services

This assessment has been conducted in general conformance with ASTM E 1527.

The scope, completed by assembly of this report, consisted of the following.

- 1) Obtain and review federal, state, and local regulatory agency records for the site and immediate surrounding area for inclusion in databases listing known areas of environmental risk and/or contamination.
- 2) Perform a site inspection of accessible areas of the property to determine the presence or likely presence of recognized environmental conditions.

- 3) Review available aerial photographs and other historical information for the site from readily available sources in order to evaluate changes in site vegetation, topography, and use.
- 4) Assess adjacent property use by observation from the subject site or from adjacent public roadways and contact local regulatory agencies, fire department, neighbors, and previous owners as may be productive in verifying historical use of the property.
- 5) Review site history of ownership, if provided by the user, to determine past uses that were, as described in E 1527-05, "likely to have involved the use, treatment, storage, disposal, or generation of hazardous substances or petroleum products."
- 6) Prepare a written report documenting the results of the foregoing evaluations and form an opinion of the presence or likely presence of recognized environmental conditions at the site.
- 7) Services associated with evaluation of site buildings, if any, for asbestos, mold, vapor intrusion, and radon are **excluded** from this scope of services.

Significant Assumptions

A Phase I ESA per ASTM standards is an assessment that is based on various assumptions. Assumptions are inherently made by the environmental professional in the site inspection, property research, and reporting tasks involved in completing the process.

In the inspection and research phase, the environmental professional has to assume that the conditions observed during the Site inspection are representative of the unaltered condition of the Site. In addition, the professional has to accept as true the information obtained from the past and present owners, regulatory officials, and other historical and publicly available sources.

In assembling all of the data obtained through the Site inspection and research procedures into a report, the professional also has to make assumptions about the extent, or lack of, impact that may have occurred from an apparent release of a petroleum product or hazardous waste. Further, assumptions have to be made concerning subsurface conditions and how the variables of soil characteristics and groundwater hydrology can affect the fate and transport of contaminants.

2. Background Information

2.1 Site Location/Land Use

The Site is located on a wooded slope adjacent to the stormwater detention pond that serves the power substation. The Site and parent property are owned by Carolina Power and Light (Progress Energy), and are located northwest of Cary, North Carolina.

The parent property is surrounded by residential use and undeveloped woodlands. A vicinity and topographic map and preliminary Site survey are included in Appendix B.

2.2 Environmental Setting

Data describing the environmental setting of a subject site is used for assessing the potential for migration of contaminants from adjoining properties or from within a parent property. Such data typically includes topographic and geologic sources that can be used to make judgments concerning the transport and fate of contaminants in air, soil, and ground water.

Soils at the Site are classified as Map Unit: WsC2 – White Store sandy loam, 6 to 10 percent slopes, eroded. White Store soils are described as gently sloping to moderately steep, moderately deep, moderately well drained soils that are found on narrow side slopes in the uplands. Permeability is slow and surface runoff is rapid. The depth to bedrock is from 4-feet to greater than 8-feet. The water table is often perched due to slow permeability in the subsoil. These soils have an acidic reaction with a pH range from 5.1 to 5.5.

The Site is in the Green Level, North Carolina, USGS topographic quadrangle. The surface elevation at the Site is approximately 315-feet above mean sea level (msl). Topography at the Site is sloped to the south toward Panther Creek.

2.3 Facility Operations

The tower facility will operate as an unmanned installation designed to support wireless telephone service equipment.

2.4 Historical Overview

A chain-of-title for the subject property, conforming to ASTM standards, is to be provided by PT Access Networks. Title research was therefore not included in the scope of this assessment.

Background Information

Mr. Chris Seawell of PT Access Networks was contacted to obtain further information about the historical use of the Site. Mr. Seawell stated that he is not aware of any environmental conditions on the property and reported no knowledge of a previous Phase I ESA or environmental conditions, liens, or activity use restrictions.

AES also contacted Fire Marshal Ken Hawley of the Cary Fire Department to obtain historical use information for the property and to check for records of fire calls, spill or HAZMAT responses to the property. Mr. Hawley has not responded to the request for information as of the date of this report. AES reserves the right to amend this report if Mr. Hawley responds with information on environmental conditions at or near the Site.

Sanborn Historical Map research was conducted for the area of the Site by EDR. No map coverage exists for the subject property.

2.5 Review of Aerial Photographs

Aerial images for several years from 1993 through 2010 were reviewed on Google Earth. These images show the Site and parent property as wooded undeveloped property with residential use on the surrounding properties. The electrical substation, which first appears in a 2009 image, appears to be the only development near the Site during this period.

Aerial images from 1981, 1988, 1999, 2005 and 2010 were reviewed on the Wake County GIS System. These images show the Site and parent property as described above.

A 1965 aerial was reviewed in the Wake County Soil Survey. This image is of large scale and low resolution making it difficult to determine the details of the Site. The Site appears to be part of a wooded, undeveloped property. There is also a field area surrounded by woods that existed close to where the Site is now proposed. No indications of industrial use or environmental conditions were noted in the aerial reviews.

3. User Provided Information

3.1 Title Records

Title records for the subject parcel were not provided by the user for review under the scope of this assessment.

3.2 Environmental Liens or Activity and Use Limitations

The user or current property owner have provided no knowledge of environmental liens against the property and no activity or use limitations other than local zoning ordinances and building codes.

3.3 Specialized Knowledge

No specialized information or knowledge has been provided by the user for the subject property.

3.4 Valuation Reduction for Environmental Issues

A valuation reduction has not been included as part of the scope of this assessment.

3.5 Owner, Property Manager, and Occupant Information

The subject property is currently owned by Carolina Power and Light (Progress Energy). Mr. Chris Seawell of PT Access Networks, a Progress Energy company, was contacted by telephone as described in Section 2.4.

3.6 Reason for Performing Phase I

This Phase I ESA has been performed to identify recognized environmental conditions for the subject Site. The user is interested in determining the likelihood of RECs at or near the subject property and assessing the potential to affect a small lease area for the subject wireless telecommunications tower facility.

3.7 Other

No other user provided information is noted.

4. Site Inspection

4.1 Inspection

A visual inspection of the Site and surrounding area was made on September 18, 2012. The investigation involved a walk-through of the Site and surrounding area to obtain information on the presence or likely presence of recognized environmental conditions at or near the property.

The site inspection included a walk of the access to the Site across the parent property, as well as a survey of the surrounding properties from public roads.

4.2 Utilities

Progress Energy provides electricity to the parent property and in the area and AT&T provides landline telecommunication service. Water service is not in use at the Site but is available in the area from the Town of Cary.

4.3 Wastewater and Stormwater

Wastewater service is not in use at the parent property but may be available in the area from the Town of Cary. Stormwater runoff on the Site is from wooded and open graded areas of parent property and is expected to follow natural and graded drainage patterns to the south toward Panther Creek.

4.4 Petroleum and Chemical Materials

There was no evidence of any petroleum or chemical materials at the Site.

4.5 Solid Waste

4.5.1 Non-Hazardous Waste

No non-hazardous waste was noted at the Site.

4.5.2 Hazardous Waste

No hazardous waste was observed at, or adjacent to, the Site. Asbestos survey for on-site buildings, if any, was not included in the scope of this assessment.

4.6 Radon

A radon survey was not in the scope of this assessment.

4.7 Polychlorinated Biphenyls (PCBs)

Pole and pad mounted transformers were observed on the electrical service lines located in the area, and large transformers are in operation in the substation. These transformers appeared to be in good condition with no evident leaks. The transformers are not located such that they would be expected to affect the subject lease area. Most power companies report that they no longer utilize transformers containing Polychlorinated Biphenyls (PCBs).

5. Regulatory Agency Database Review

5.1 Database Listing

AES obtained a search of applicable and accessible federal, state, and local databases within a designated radius of the Site from Environmental Data Resources, Inc. This database search is designed to determine whether the Site or neighboring sites have a regulatory history of environmental problems that could have an adverse impact on the subject property. 5.2 On-Site Potential Sources of Contamination

EDR reported no on-site potential sources of contamination.

5.3 Off-Site Potential Sources of Contamination

EDR reported no mapped, but several unmapped, off-site potential sources of contamination. The unmapped records were reported by EDR with limited and incomplete address information. An examination of both the estimated location and listed status of these records was conducted to determine if they are likely within the ASTM radii of being a potential source of contamination. The address information provided for each unmapped record was cross-referenced with the streets that intersect within a one-mile radius of the Site in an attempt to determine the proximity to the Site.

Based on the above described analysis of the limited address information provided and the reported status of each remaining unmapped record, it has been determined that they are not expected to affect the lease area. See Appendix C for details on each record listing.




