Dear Ms. Kiddoo:

SNR Wireless LicenseCo, LLC and Northstar Wireless, LLC (jointly referred to herein as “Applicants”) request an extension of time until 3:00 pm on October 1, 2015 to submit either (a) the additional payment or (b) the irrevocable, standby letter of credit (“LOC”) required by paragraphs 153, 155, 158 and 160 of the Commission’s *MO&O* in this proceeding.<sup>1</sup> Applicants submit that good cause exists for the Wireless Telecommunications Bureau to grant the requested, brief extension of time. The *MO&O* gives rise to new and complex business issues that Applicants must resolve before they can meet the payment or LOC requirements of the *MO&O*. Providing an additional two weeks, until October 1, 2015, will allow Applicants the time necessary to resolve these issues. Further, Applicants confirm that, in the event that they elect to deliver LOCs instead of making the payment, the date for ultimate payment will remain December 16, 2015. For these reasons, Applicants respectfully request that an extension of time until 3:00 pm on October 1, 2015 be granted to make their elections pursuant to paragraphs 153, 155, 158, and 160 of the Commission’s *MO&O*.<sup>2</sup>
