The applicant herein is Ligtel Communications, Inc. (“Ligtel” or “Applicant”), an Indiana corporation that is a provider of Internet access, long distance telephone and other telecommunications services. Ligtel is a wholly-owned subsidiary of Ligonier Telephone Company, Inc. (“Ligonier Telephone”), an Indiana corporation that has been providing telecommunications services since 1896. Ligonier Telephone currently provides local exchange telephone service to approximately 2,200 access lines, including all affiliates. Ligonier Telephone qualifies as a “rural telephone company” under Section 1.2110(c)(4) of the Commission’s Rules. Its principal offices are located at 414 S. Cavin Street, Ligonier, IN 46767.

Consistent with the instructions set forth in the Commission’s *Public Notice* entitled Auction of Advanced Wireless Services (AWS-3) Licenses in the Scheduled for November 13, 2014, DA 14-1018, AU Docket No. 14-78 (Auction 97) (*rel.* July 23, 2014), Applicant has provided the information and made the certifications required by Rule Section 1.2105(a)(2) through its completion and execution of FCC Form 175.

Real Parties in Interest

Ligonier Telephone and its owners, members of the Schloss family, are the real parties in interest with respect to this application.

Applicant’s Direct and Indirect Owners

Applicant has identified the Robert P. Schloss Family Credit Shelter, Mrs. Meshell Schloss and the Phil Schloss Family Trust as the only individuals and entities that hold ten percent or more of the issued and outstanding voting stock of Ligonier Telephone. Meshell Schloss is the Trustee of the Robert P. Schloss Family Credit Shelter, and together with interests that she holds directly, controls 50.75% of the voting stock of Ligonier Telephone. The remaining issued and outstanding voting stock of the Applicant is held in amounts that are less than five percent by or on behalf of individual members of the Schloss family. Applicant has identified the following FCC Regulated Businesses in with it and its owners have a 10% or greater interest:

Ligonier Telephone Company, Inc.

As indicated above, Ligonier Telephone is an Indiana corporation and provider of local exchange telephone service that is owned and controlled by Meshell Schloss and members of the Schloss family. Its business address is at 414 S. Cavin Street, Ligonier, IN 46767.

Heartland Cellular, Inc.

Heartland Cellular is an Indiana corporation that is 100% owned by Ligonier Telephone. Heartland Cellular holds Ligonier Telephone's indirect 25% interest in the Indiana RSA 2 Limited Partnership and its business address is at 414 S. Cavin Street, Ligonier, IN 46767.

Indiana RSA 2 Partnership

Heartland Cellular owns a 25% partnership interest in the Indiana RSA 2 Partnership (the “RSA 2 Partnership”). The RSA 2 Partnership holds the Channel Block B cellular license for the Indiana 2 - Kosciusko RSA under Call Sign KNKQ299. The business address of the RSA 2 Partnership is at One Verizon Place (MC: GA3B1REG) Alpharetta, GA 30004-8511.

Indiana Fiber Network, LLC

Ligonier Telephone has a 20.44% ownership in Indiana Fiber Network (“IFN”), an Indiana limited liability company that was formed in 2002 to provide fiber transport services to its members, which currently consist of nineteen (19) independent telephone companies. IFN’s business address is at 5520 W. 76th Street, Indianapolis, IN 46268.

Hoosier Tower & Telecom, LLC

Ligonier Telephone owns a 50% interest in Hoosier Tower & Telecom, an Indiana limited liability company that was formed in 2004 in partnership with Emergency Radio Service, Inc. (“ERS”). ERS is an Indiana corporation and Motorola dealer. Its business address is at 414 S. Cavin Street, Ligonier, IN 46767.

Indiana Video Network, LLC

Applicant is a member of Indiana Video Network, LLC, an Indiana limited liability company that was formed in 2004. This LLC was created to jointly own and operate a shared video head end, using capital contributions of the members. The principal office of IVN is at 1600 Market Tower, 10 West Market Street, Indianapolis, IN 46204.

Additional Certifications

Applicant utilizes a law firm that represents other applicants in Auctions No. 97 and a member of Applicant’s law firm has been authorized to perform bidding duties on behalf of the Applicant. Law firm personnel working with Applicant have not been involved in any discussions regarding bids or bid strategy and shall not perform bidding duties for any other client/applicant that has specified licenses on its short-form application that are the same or that have geographic overlap with those of the Applicant. Moreover, ethical wall procedures have been implemented to ensure that the law firm’s other clients cannot learn any information about Applicant’s bids or bid strategies or plans for the post-auction market structure, and vice versa. Similarly, Applicant utilizes a consultant that may work with other applicants in Auctions No. 97. Applicant’s consultant has been authorized to perform bidding duties on behalf of the Applicant. Ethical wall procedures have been implemented to ensure that the consultant’s other clients cannot learn any information about Applicant’s bids or bid strategies or plans for the post-auction market structure, and vice versa. Applicant and its representatives and consultants certify that they will abide by the ethical wall arrangements and will not engage in any restricted communications until after the down payment deadline, as such terms are defined in 47 C.F.R. § 1.2105(c).

Applicant certifies that it is not in default on any Federal Communications Commission (“Commission”) licenses and that it is not delinquent on any non-tax debt owed to any Federal agency.

Applicant states under penalty of perjury that it has never been in default on any Commission license and that it has never been delinquent on any non-tax debt owed to any Federal agency.

Applicant certifies as truthful, under penalty of perjury, that it has not entered with any other party into any partnership, joint venture, consortium or other agreement, arrangement or understanding of any kind relating to the licenses being auctioned in Auction No. 97, including any such agreements relating to the post-auction market structure.

Applicant further certifies, under penalty of perjury, that it has not entered and will not enter into any explicit or implicit agreements, arrangements or understandings of any kind with any party regarding the amounts of their bids, bidding strategies or the particular licenses on which they will or will not bid.
